**PUBLIC PARTICIPATION:** Candi and Steve Smith asked about the junk on the property at 2756 CR 605. Almendinger asked Dattilo to check about any vehicles and possibly the Health Department.  
Ron Van Winkle spoke about the Comprehensive Plan. The audience did not want the overlay map. They like the idea of conservation subdivision and want to keep at 3-5 acres. Almendinger said that we have a TIF over the township and he felt that you can't fault people wanting to sell their land for high dollars. Justice said we don't have sewer or police to offer the landowners. Justice said the Comprehensive Plan is what we want

**BSTG FIRE DEPARTMENT:** Fisher reported that in October there were a total of 162 runs with 21 being in Trenton Township. There were some part-timers that resigned and they have hired two additional firefighters to pay with budget decreases. The Board will open the bid for the building next Wednesday. Approximate cost is 5.3 mil with Delaware Co. paying one-half. Fisher said there are no plans for equipment or additional personnel. Bond cannot be used to buy fire apparatus. Left-over money from the Bond will go back to the taxpayers.

**CEMETERY DEEDS:** Trustees signed deed for Cheryl Wampler (changed grave plots from last deed)

**ZONING INSPECTOR REPORT:** Dattilo reported that he had attended the DRPC, BZC, and Trustees meeting. He is now on #23 for Zoning which is really slow compared to last year. January 16 is the next BZA/BZC meeting.
